Objectives:

- The CME will help Teaching faculty to upgrade their existing knowledge.

Eligibility:-

- Teaching faculty of concerned subject i.e. Agadatantra working in any Ayurvedic College recognized by Ministry of AYUSH.
- Those who have already attended 2 CME programmes of AYUSH in a year are not allowed to apply.

Maximum No. of participants:-

30 (Maximum 5 participants from each states)

Duration of Training Programme: -

06 Days (Exclusive of Journey Time)

Procedure of Application and submission:-

Duly filled application forms along with a true copy (Self attested) of **Registration and UG & PG Degree Certificate** and **Aadhar Card** should reach the coordinator on or before due date specified against the programme schedule. Application received after the due date or incompletely filled application forms will be rejected. The applicant should clearly mentioned “**Application for CME in Agadatantra**” on the top of the envelope while sending the application form. Application can be sent through e-mail as advance copy on agadakats@gmail.com.

Payment of TA :-

- All transactions will be made only by electronic transfer through banks.
- No amount will be paid to trainees except the reimbursement of traveling expenses that too on actual basis as per the rules subjected to ceiling.
- Payment of TA should be made only at the end of the training programme after obtaining full attendance as per admissibility or actual whichever is less.
- Places were connected by rail will be reimbursed with actual fair limited to AC Two Tier or actual claim, whichever is less.
- Road millage is allowed only for places not connected by rail. With regards to road millage, actual rate but not exceeding approved rate under TA Rules. Claimant should mentioned distance between the places.
- The Payment of TA will be made on production of original tickets by the trainees. The payment will be made as per CME guidelines.

NB:- TATKAL or dynamic pricing train tickets will not be reimbursed.

Boarding and Lodging Charge:

Decent lodging and boarding facilities will be arranged for all the outstation trainees.

Participation certificate:

Full attendance is mandatory for obtaining participation certificate. Participation certificate will be issued at the end of the CME.

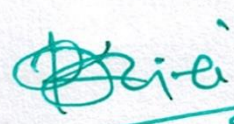

- Food expenses during journey up to maximum Rs.175/- will be paid on production of bills. No food expenses will be paid if journey is made by Shatabdi/Rajdhani/Duronto trains.
- Payment will be made directly to the bank account by electronic transfer.
- Reimbursement of the journey performed by road is permissible for the places which are not connected by rail. The road mileage will be limited 1 AC rail charges or actual claim, whichever is lower.
