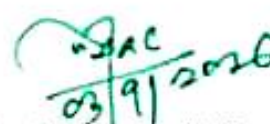

CORRIGENDUM

to

Request For Proposal (Tender Call Notice) No. 1985/KATS, dated 03.09.2026

In partial modification of the provisions contained in the tender book of the **Request For Proposal (Tender Call Notice) vide No. 1985/KATS, Dated 03.09.2026** issued for selection of a Manpower Service Provider for providing 16 nos. of outsourcing personnel comprising 01-Photographer, 01-Gardener, 01-Watchman and 13 nos. of Sweepers on outsourced basis at K.A.T.S. Ay. College & Hospital, Ankushpur, Ganjam, the **Tie-Breaking Criteria for selection of L1 bidder** is hereby modified in accordance with **Rule 264(iv) of the Odisha General Financial Rules (OGFR), 2023 as amended** ensuring transparency, fairness and equal opportunity among the technically qualified bidders.

Accordingly, the existing provision relating to the **Tie-Breaking Criteria for selection of L1 bidder** on the basis of “**higher turnover (Average Turnover during the last three Financial Years)**” in case two or more bidders quote the same lowest price shall stand deleted.

The following provision shall be substituted in its place:

1	Technical Bid Evaluation section on Page No. 29	In case of tie among the two or more L1 bidders	on the basis of higher turnover (Average turnover in last three Financial Years)	Through a transparent system of lottery among the tied bidders.

The lottery shall be conducted in a transparent manner by the duly constituted Tender Committee of this institution in the presence of the eligible tied bidders or their authorized representatives, who may wish to remain present.

The names of all such tied bidders shall be entered in identical slips / lots and placed in a suitable container in a manner ensuring transparency and fairness. The bidder whose name is drawn through the lottery shall be declared **L1** for the purpose of selection and award of the contract.

The proceedings/results of such lottery shall be properly recorded in the minutes/ proceedings of the Tender/Selection Committee and shall form part of the tender record.

Except for the above modification, all other terms, conditions, Date, Time, eligibility criteria, scope of work and provisions contained in the Tender Book of Request for Proposal (Tender Call Notice) No. 1985/KATS, dated 03.09.2026 shall **remain unchanged**.

This Corrigendum shall be deemed to form an **integral part of the Tender Book** and shall be read in conjunction with the original Tender Call Notice and Tender Book.

All prospective bidders are requested to take note of the above modification while submitting their bids.

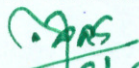

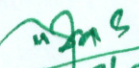
